The defendant, in the County of New York, during the period from on or about February 4, 2025, to on or about January 16, 2026, intentionally advanced and profited from prostitution by using force and engaging in a scheme, plan and pattern to compel and induce a person being patronized to engage in and continue to engage in prostitution activity by means of instilling a fear in said person being patronized that, if the demand was not complied with, the defendant would cause physical injury, serious physical injury, and death to said person.

SECOND COUNT:

AND THE GRAND JURY AFORESAID, by this indictment, further accuses the defendant of the crime of **SEX TRAFFICKING**, in violation of Penal Law §230.34(5)(h), committed as follows:

The defendant, in the County of New York, during the period from on or about February 4, 2025 to on or about January 16, 2026, intentionally advanced and profited from prostitution by using force and engaging in a scheme, plan and pattern to compel and induce a person being patronized to engage in and continue to engage in prostitution activity by means of instilling a fear in the person being patronized that, if the demand was not complied with, the defendant would perform any act which would not in itself materially benefit the defendant but which was calculated to harm the person who was patronized materially with respect to her health, safety, and immigration status.




